1. Treatment Details

A. Drilling & Injection (Ground Floor/Basement Area Only)

- Drill holes every 3 to 6 feet along floor slabs and wall junctions.
- Inject Fipronil solution under pressure for deep, long-lasting protection.

B. Fumigation & Rodent Control (Entire Building)

- Application of Lambda and Chlorpyrifos through manual spraying.
- **Targets and eliminates:**
 - Cockroaches and mosquitoes
 - Rats and rodents (traps and baiting where required)
 - Other crawling and flying insects
- Non-staining, odorless, and colorless formulation—safe for indoor use.

2. Products Used

- **Legend® (Fipronil 2.5% EC)** – Termite control formulation
- **Ranger® (Fipronil 4.5% EC)** – Deep barrier treatment
- **Chlorpyrifos (20% EC)** – Broad-spectrum fumigation
- **Lambda (2.5% EC)** – Insect and mosquito elimination

All chemicals are registered for commercial pest-control use in Pakistan and sourced from Ali Akbar Group and other reputable suppliers.
