NUTECH/SCM/Deployment of ODOO and OPENEDUCAT -2019/TD-049

With reference to tender no **NUTECH/SCM/ Deployment of ODOO and OPENEDUCAT - 2019/TD-049** advertised on PPRA on 11 March 19 and NUTECH website, it is to be noted:-

- (a) Date of opening of tender has been changed from **28 March 2019** to **08 April 2019**. Submission time and tender opening time will remain same as previously advertised.
- (b) Various amendments/additions have been made in tender document are as follow:-

1. The title of tender be read as
“Deployment of ODOO along with any compatible open source CMS/LMS which can be seamlessly integrated with Odoo, and Requirement Gathering for future development of NUTECH CMS, LMS and ERP systems”
2. The submission date to be extended to **8 April 2019 at 1030 hours**. Opening will be at 1100 hours.
3. For all mention of **“OpenEduCat”** in RFP, read:- **“Any compatible open source CMS/LMS which can be seamlessly integrated with Odoo”**
4. Addition in Section 2 Project Objective Page 10

For the following sentence:-

“Add Odoo’s accounting for 5 users, Inventory for 2 Users, Payroll for 2 users without any customization”

Read as :-

“Deployment of accounting, inventory and payroll Odoo apps for which the software and licenses will be provided by NUTECH”

5. Addition in Section 2 Project Objective Page 10

6. Change in General Requirements Source Code & Updates last point

“The customization made in the original source code or any new source code created for NUTECH by the vendor shall be the exclusive property of NUTECH. The vendor will not have rights to modify and resell/redistribute the customized product or part of it to other organizations”.

7. Addition in TOR Section 4 Page 10

It must be noted that NUTECH needs the services of the firm for implementation of Odoo with any compatible open source CMS/LMS which can be seamlessly integrated with Odoo; Requirement Gathering and Roadmap for future development. The project duration is set to 06 months and will include deployment of baseline system of Odoo for which no new development, but only minimal / necessary customization is required. The accounting, inventory and payroll apps will be licensed, the procurement of which will be the responsibility of NUTECH.
