3	What is the maximum limit of a single work order?	The maximum limit of a single work order is 2.0 Million.		
4	How much time is required to process the bill?	After Completion / handover of a project, the bill is processed within 15 working days.		
5	What is the meaning of most advantageous bid?	Refer to PPRA Website – Rules, General Provision, Definitions h (i) (ii).		
6	Is Performance Security accepted from any insurance company?	Refer to clause no. 21.1 of bidding data in Standard Bidding Documents.		
7	Is Pre Bid Meeting mandatory?	Pre Bid Meeting is not mandatory at this time.		
8	Is the bidder required to only provide a letter of offer, since this is the Single Stage Single Envelope (SSSE) bid?	Refer to clause no. 8.1 (A) of bidding data, the bid prepared by the bidder shall comprise the components written in abovementioned clause.		
9	How works will be executed under this contract?	As this is the Framework Type Contract, all works under this Contract will be executed on "as and when required" basis. For each minor work (new work) necessary detail of work including Bill of Quantities / Drawings will be provided.
